This proposed 319 NPS grant project addresses a critical need for hazardous waste disposal in Ravalli County, and informs the public about the need for safe, proper disposal of hazardous waste. Last year's hazardous waste events succeeded in collecting over 48 tons of hazardous material in Ravalli County. To Whom It May Concern:

This letter is in support of the Bitterroot Valley Hazardous Waste Disposal Project. As the Board of Health for Ravalli County, we constantly address the issue of potential water quality degradation.

Holding a second, much-needed countywide hazardous waste collection event would address a critical need in our county by eliminating many potentially dangerous chemicals, thereby keeping them out of our ground water. Currently, such an important event is beyond what our cash-strapped county can afford, but it is something we desperately need. This need was demonstrated in May of 2008 when we collected 24 tons of hazardous waste and again in September 2008 when we took in another 24 tons of electronic waste!

With approximately 75 percent of county residents on individual, on-site septic systems, it is crucial that an alternate means of disposal be offered to citizens. Unfortunately, Ravalli County does not have a secure source of funding for an annual event. We believe, by offering the community a few grant-funded events, we can educate the citizens on the importance of generating local funding for water quality protection. Response during our collection events in 2008 was overwhelmingly positive, and we already made great strides in our public outreach efforts.

Last year's collection events were a collaborative effort among citizen volunteers, local municipalities, and many community organizations.

Growth in Ravalli County will continue, and we are under increasing pressure to protect our highquality natural resources. This project is vital in helping reach that goal.

The Board of Commissioners for Ravalli County wholeheartedly supports the proposed Bitterroot Valley Hazardous Waste Disposal Project.

Safe and legal hazardous waste disposal has always been difficult in Ravalli County. For years conscientious citizens had to take their used oil, paints and the like to Missoula for disposal, because our county did not have an organized collection event.

Recent efforts by our county's Environmental Health Department have made the situation much better. People can now take their fluorescent bulbs to Ace Hardware in Hamilton, and Lube Quik accepts used motor oil year-round. But this year's two organized collection events proved that there's a tremendous amount of hazardous material out there that needs to be disposed of properly.

As commissioners, we are looking at ways to fund an annual collection event, but with our current budget, there's no way we can do it this year.

Funding another collection event in 2009 will help protect Ravalli County's air and water and will give us time to develop a long-term strategy for hazardous waste collection.

We urge you to help Lea Jordan, Ravalli County Environmental Health Department and the citizens of Ravalli County in protecting the water quality in the Bitterroot Valley by funding this worthy project.
